October 2015 Minutes

Regular meeting of the Cherry Ridge Township supervisors was held October 6, 2015 at 7:00 P.M. at the municipal hall. Present were John Rickard, Peter Suhosky, Dave Sporer, Scott Bennett, Jim Burns, Brandon Ellis, and Lars Anderson. John made a motion to approve the minutes and Dave 2nd it. Scott presented his report and recommendation on the Harwith Communications hearing. His recommendation is that they have met the requirements of set backs, weight limits on roads, and buffers. Lars asked about the buffer – he is proposing an eight foot wire fence around the cell tower. The pattern for the township has been the property lines. John would like to talk to the adjoining property owner for his input as to the wire fence and dense evergreen. John made a motion to approve the solicitor's report and recommendation and will let Lars know the type and location of buffer required. Dave 2nd it. Scott is working on notice of violations and will send them to Steve Ostrander. Dave reviewed the emergency management mitigation plan and did not see anything detrimental. Dave made a motion to adopt the county's mitigation and John 2nd it. Jerry presented a letter for Texas Rod and Gun Club to name their road – Log Road. Dave made a motion to allow Texas Rod and Gun Club to name their road Log Road and John 2nd it. John made a motion to approve the bills and Dave 2nd it. Pete made a motion to adjourn and Dave 2nd it. All motions were carried unanimously.
