The regular meeting of the township supervisors was held March 1st at 7:00 pm at the municipal hall, present were John Rickard, Dave Sporer, Brendan Ellis, Steve Ostrander and Jim Lapoint. John made a motion to approve the minutes, Dave 2nd. John reported there were a few wash outs and drains plugged on the roads, that they repaired and had wayco repair. Dave stated Pete mentioned Jim Lapoint of cwra may come to the meeting. Dave spoke to Jim Martin about the grant, they are held up because of the budget. He has a call in to see if they will be released before a new budget. He also reported Fred Deihl is coming to remove the fuel tank. Steve brought in a cd for Brendan on cadjaw violations, he spoke on its contents. He also reported someone called him for a demo permit but the township does not have one. John made a motion to allow the hall to be used for the elections, Dave 2nd. Jim addressed the board about the sewer authority, he reported engineering is done and they are working on permits for White Mills project. They have financing and are working on easements, hoping to start in June/ July lasting 1/ 2 years. They rebuilt 9 pump stations in Cherry Ridge in 2015. His term expires in 2017 but will accept a nother 5yr. Term if the supervisors wish. Dave made a motion to approve the bills, John 2nd. John made a motion to adjourn, Dave 2nd. All motions were carried unanimously.
