John made a motion to approve the minutes, Pete 2<sup>nd</sup>. Dennis addressed the board about the Flynn lot consolidation, he addressed the counties concerns. John made a motion to approve the Flynn lot consolidation, Dave 2<sup>nd</sup>. Dawn Crumb addressed the board, she is a property owner oc cadjaw and has someone( Gerald Hill) with campers on her property. Her property is between his 2 lots. Brendan asked which lots are in violation, Steve stated all of them he believes the campers are on all of the lots. Dawn has a action against him for trespassing but her property is still in violation. Steve suggested sending a violation to Gerald, the board agreed. They suggested sending a violation and to check in at next months meeting June 7<sup>th</sup>. Brendan reported he did not hear from any other violators. Steve mentioned he heard from Joseph Cleary, he needed a permit and the permit is approved, and the supers will waive the fines. Shykofsky called but Steve could not get in touch with them.
