The regular meeting of the township supervisors was held July 5<sup>th</sup> at 7:00 pm. At the municipal hall, present were, John Rickard, Dave Sporer, Steve Ostrander and AG Howell. John made a motion to approve the minutes, Dave 2<sup>nd</sup>. AG spoke on the use of the proposed soccer field. There are 5 teams that want to use the field. It would just be a parking lot and the field no buildings. They submitted a conditional use application, it went before the Cherry Ridge planning board and was forwarded to the county planning. 2 problems were water and sewer. Intent is for practices 6:00pm till dusk maybe 2 teams on Saturday. They would have a small shed for mower and equipment. They currently have a 3yr lease with the hospital with an option to renew. John stated he wished they started this earlier and the proper channels were taken. AG hoped to ask for a temporary permit for 3 months. John stated he would not approve such a permit. Dave stated he would but because only 2 supervisors were present it could not be voted on. AG feels there needs to be no permit and asked again for the supervisors to think about the temporary permit. Dave described how planning county and supervisors look over conditional use. Steve asked what AG meant by asking for a permitted use, AG wanted to be clear if its conditional use or permitted. Steve deemed it is private and then requires conditional use. Steve addressed the board about the Brushard property. It appears he is doing commercial work on his property again. Dave will speak to Brendan about it. John made a motion to appoint Ronnie Fisher to be solicitor of the Cherry Ridge Zoning hearing board, Dave 2<sup>nd</sup>. No bids were received on the truck. John made a motion to approve the bills, Dave 2<sup>nd</sup>. Dave made a motion to adjourn, John 2<sup>nd</sup>. All motions were carried unanimously.
