All such reasonable legal, engineering, consulting fees or other costs, however denominated, associated with the Township's review, inspection, reinspection, and evaluation of any and all plans submitted to the Township in association with any application, including preliminary and final applications.
- 4. The Board of Supervisors reserves the right to reduce or return any fee where, in the sole discretion of the Board, adequate mitigating circumstances exist.

5.	The Township explicitly reserves the right to rescind any permits or approvals issued by
	the Township if the applicant fails to pay any Supplemental and Final fees associated
	with such permit or approval within thirty (30) days after the billing date thereof.
