The regular meeting of the township supervisors was held July 5th at seven pm. At the municipal hall, present were, John Rickard, Mark Lienert, Peter Suhosky, Scott Bennett, Shiela Waring, and Linda Suhosky. John made a motion to approve the minutes, Pete 2nd. Linda approached the board representing Lake Cadjaw Association. Apparently they have no damn permit according to DCED. They are applying for it and a gambling grant and is asking for the townships support. John made a motion to sign a letter prepared by her showing the supervisors support, Mark 2nd. Pete asked Jerry if he had looked into the DOT #'s and cost. Jerry replied he did not. Mark stated he would look into it. Shiela Waring asked if something could be done about Mang rd. that is washed out, The board told her they are aware of it and will get to it as soon as they can. Mark spoke to Pete Gregory, he said there is only 3 volunteers on the Honesdale Ambulance. Scott stated the twp. Can enact ordinances concerning ambulances and fire companies. Mark reported that Jerry told him of another potential liability for the Ciarrochi accident, concerning Jason Barnes. Jerry forwarded the letter to the insurance company. John made a motion to to authorize Scott to look into the ambulance insurance, Mark 2nd. Scott reported he received a letter from Robert Miller from Blue ridge cable stating they will donate the 15,000.00 if they draw up a new contract dating back to 2006. Scott suggested he draws up the contract instead. Mark made a motion to allow Scott to draw up the contract, Pete 2nd. Mark reported there is a new ambulance coming into town, Wayne ALS from Lacawanna county to be stationed at Texas #4. Marty Hedgelon asked if the township wants to have a new resolution. Scott wonders if they have joint billing? Pete asked Scott to send them a letter and find out if they have any agreements. Pete reported Tom Shepstone approached him out of the meeting and stated he heard the twp. Was not happy with his bill. Then went on to say he does not want to do anymore small jobs like this. After reviewing the past bills and payments the township still owes 1375.00. Scott proposed if he does not want to complete the job then the twp agree to pay 1/2 or 700.00. Mark made said motion, john 2nd. Mark made a motion to approve the bills, Pete 2nd. Pete made a motion to adjourn, Mark 2nd. All motions were carried unanimously.
