Pete believes it should be closest possible, John stated Cherry Ridge is very fortunate to have so many available. Mark feels making a change will cause problems with everyone. He suggested having them at a meeting. Scott was going to ask Marty and all ambulances to come to the next meeting. Mark made a motion to approve the bills, John 2<sup>nd</sup>.
