

April 2012

The regular meeting of the township supervisors was held April 3, 2012, at 7:00 P.M. at the municipal hall. Present were John Rickard, Mark Lienert, Peter Suhosky, Scott Bennett, and Don Hiller. Pete made a motion to approve the minutes from March 2, 2012. Don addressed the board about the emergency plan for the township. He needs help with the forms and needs to know of any special needs of residents. John suggested putting something on the website so if people saw it they could call the township and could get a list. Pete will write something to put on the website to update emergency management. Don also asked Ed Coar and anyone with knowledge of commercial property in the township. Mark presented a study from Texas Township to extend the sewer, delivered to him and signed for. Scott was going to review it. He also spoke to Mr. Richards by Lake Cadjaw who was having a problem with his property and water problems. He then had a problem with his neighbor. John presented a worksheet for road repairs to be put out for bid. Pete asked about weight signs. John stated they would be up soon. Pete reported the website was down for 3 days and both he and Mark went to the spring meeting. Brian Smith did well speaking at the meeting and they learned natural gas price was at a 10 year low. Scott reported the property on Racht Road has been served. The bank has the property FannieMae, but there may have been a problem with the form Act 91 and they may not have a good title. There is someone living in the home. Maybe we should site them. Mark made a motion to allow Scott to serve a violation to the occupant by a constable. John seconded it. Scott also reported he received a message from Rolin Edwards telling him there are no violations on the Robinson property. Scott also drafted and proposed a resolution to authorize the com center to use its discretion on when it dispatches to emergencies and recognizes Honesdale as the designated server. John made a motion to adapt Resolution #120403. Pete seconded it. Don spoke of a accident in the township where many ambulances were there but none would work together. Mark asked Scott to add Wayne Ambulance to all notified of ordinance and a letter wanting to have them all along. Also he is sending a letter to Blue Ridge requesting they supply required documents to township specifically on insurance. he was also sending out a letter to Lakeside Mobile Homes for fees due. board asked Jerry to advertise for road work and agreed to hold a special meeting on the 23rd of April, 2012, to open bids. Mark made a motion to approve the bills, Pete seconded. John made a motion to adjourn, Pete seconded. All motions were carried unanimously.
