The regular meeting of the township supervisors was held July 2<sup>nd</sup> at seven o'clock at the township hall present were John Rickard, Mark Lienert, Peter Suhusky and Scott Bennett. John made a motion to approve the minutes, Mark 2<sup>nd</sup>. Scott reported on the Robinson hearing before the majesterial justice, Robinson did not appear and a judgment near \$3,900.00 was entered in favor of the township. Both atty Bennett and chairman Suhusky were present. There is a thirty day appeal period. John made a motion to seek an order compelling Robinson to remove the trailer from the property. Peter 2<sup>nd</sup>. Scott then reported on Johns question of clearing right of ways. The township can clear branches and brush in the right of way up to 6" in diameter that impair the right of way. They cannot cut a tree with a trunk in excess of 6" in diameter without telling the homeowner. He also reported on Deleware arms, he is playing phone tag with there solicitor. Mark looked at the cadjaw property dispute with the logging trucks, Joseph Bughad is in violation. Pete was going to contact Steve Ostrander about it. Jerry presented his subdivision that he failed to record in time asking the board to re sign the maps. Mark made a motion to re approve McDonald maps, John 2<sup>nd</sup>. Mark reported they will have the roads cut soonm. Peter made a motion to approve the bills, John 2<sup>nd</sup>. Mark made a motion to adjourn, John 2<sup>nd</sup>. All motions were carried unanimously.
