John made a motion to approve the minutes, Mark 2nd. Frank addressed the board that he is cleaning up the Jilling property on cadjaw and is asking for a additional week to finish. The board agreed but it has to be done in a week and someone from the township notified or further action will be taken. Butch addressed the board about the association they formed called Miller farm property Ass. To maintain the common road. He stated the fire company told them they would not respond if the road is in ill repair. Tom also spoke about the road and would like to change the name for GPS. He states the road was never deeded so knowone owns it. Steve addressed the board about the Glucksnis property on cadjaw, Glucksnis wants to set up a meeting with Steve one day this week. He also received a call from someone wanting to put up a shed. Steve has a half dozen questions about they can build on the lots, it seems they are not meeting set backs in trailer parks and such. John asked Jerry to send a letter to Roeder and Cherry Ridge campsites stating there will no longer be a permit for the entire property, but individual ones for each lot. Mark made a motion to authorize Steve to put a stop work order on Roeder trailer park John 2nd. Steve also stated there are two trailers with new decks which are in violation. Steve asked about how driveway permits are issued in the twp. And if the application could be posted on the web site. Mark brought up the Robinson proprty, the board discussed how to pursue thden tabled it till next months meeting. Pete signed up for a class of operator training for above ground storage tanks. John made a motion to approve the bills, Pete 2nd. Mark made a motion to adjourn, Pete 2nd. All motions were carried unanimously.
