One from Myrtle Road. He also checked on the car in the right away at Lakeside. The car and owner were there. He told the owner that if the car was there next time, it would be towed. Mark made a motion to approve the bills. Pete 2nd. John made a motion to adjourn. Pete 2nd. All motions were carried unanimously.
